## The TELEBIB2 standard

- TELEBIB2 is a **data exchange standard** made by and for the Belgian insurance industry.  
(Do not mix up with a standardized insurance data model or with a legal referential)
- TELEBIB2 is not limited to data exchanges between insurers and brokers.

# How to participate and submit normalization requests?

- Every industry player can join the work group Normalisation and submit normalisation requests.
- The standard (classic) work group meets 1x / month during 4h (Specific work groups are sometimes organized)

## State of play

- Sector statistics: see [BLOG \(Cuisine\)](#)
- In 2023, 97.827.861 messages were exchanged between companies and brokers, an increase of 7% compared with 2022.
- Data quality: To continue to improve to avoid extra complexity, cost and implementation time to process files.

## State of play: Evolution to JSON

- Players do not generally want to make new data exchanges in EDIFACT.
- Players do not generally intend to change their current exchanges in EDIFACT.
- Be careful with “fake” JSON exchanges:

- Aligned with the implementation cycle of the insurers:
  - Scope cut-off at the end of September at the moment of the budget approval for the next year.
  - Implementation during year n+1 (UAT from October).
  - Use in Production from the 1st of January year n+2.

**Officially: Time to close the scope for the release 2026  
(use in prod from 01.01.2026)**

## Time-to-market...

- However, to improve time-to-market, the members of the Strategic Committee Normalisation have requested players to shorten the implementation time.
- That's why normalisation work done in 2024 has continued to feed the scope of the release 2025 instead of 2026.

### **Reason why:**

**The scope of the release 2026 is not defined yet.**

## Release sheet structure

1. Functional and contextual description of the changes.
2. Impacted messages highlighting new, deleted and updated fields
3. List of new, deleted and updated fields.
4. Fields obsolete from 2025 and to be implemented by 01.01.2025.
5. List of changes in values lists.

# How to see changes for specific messages?

1. Open the MIG. If a version 2025 exists, it has been modified.
